#### Instructor

I, April Colon, was a certified lifeguard, head lifeguard, and Aquatic Supervisor for over 15 years in the town of Monroe, CT. I was Water Safety Instructor Certified through the Red Cross during this time. In addition, I have taken CPR, First Aid, and AED training every year. I started teaching swim lessons in 1997, and have continued to do so for over 30 years, with nearly 100% success rate for participants. I teach all ages, abilities, and swim team readiness.

# Lessons

All lessons will take place in Monroe during the spring/summer, and in Derby during the fall/winter. All private and semi private lessons are scheduled in 30 minute increments. Small group lessons are 1 hour long 4 days a week (available in the summer only). Lesson time may fluctuate based on the swimmer's physical abilities, attention span, and willingness to learn during the lesson. You do have the option of scheduling two 30 minute sessions back -to- back, in order to create one 60 minute session, if there is more than one individual. Participants choosing this option will be charged for two lessons.

#### Fees

Private swimming lessons are sold individually (\$65) per lesson, semi-private (\$80), or group lessons (\$280 for the 4 days, 4 hour lessons) **Payment is due prior to or at the time of the lesson.** 

## **Cancellation Policies**

Signature of Swimmer/Parent

If for any reason you need to CANCEL a lesson, 24 hour notice is REQUIRED. All lessons canceled less than 24 hours prior to the scheduled day/time will be CHARGED IN FULL.

In case of inclement weather, lessons will be rescheduled (This will be determined by me–i.e. storms, thunder, lightning, torrential rain. Lessons will take place in the rain, however with thunder or lightning lessons will be rescheduled!

We reserve the right to cancel the swim lessons without refund if the swimmer is extremely disorderly, inappropriate and/or creates a risk of harm to his or herself or others. Inappropriate conduct includes, but is not limited to the following: biting, scratching, spitting, etc.
